NC TAX BREAKDOWN

According to SmartAsset.com, North Carolina is a "moderately tax-friendly" state. However, people relocating will find plentiful financial reasons to move here. Social Security income is not taxed in North Carolina. Low property taxes and sales taxes keep the overall cost of living low.

ADDITIONAL TAX INFORMATION

Social Security Tax

Social Security is not taxed in the State of North Carolina. All Social Security retirement income can be subtracted from your taxable income when you file a North Carolina income tax return.

Vehicle Tax

At registration, 3% tax is due when your title is transferred over. Revenue from this tax is regularly allocated to the maintenance of the NC highways. Property tax on vehicles is determined by multiplying the combined county and municipal district tax rate by county.

Sales Tax

NC's total state and average local sales tax rate is 6.9%. This ranks as the 25th highest in the nation. Unlike many states, North Carolina taxes groceries, albeit at a reduced rate. The rate on most food is 2%. Prescription drugs are fully exempt from the sales tax, however.

Other Taxes To Note

NC recently eliminated its estate tax. Anyone who is planning on leaving wealth or property for their loved ones need not worry about that. Retirees with investment income outside of a retirement account should be aware that capital gains in NC are treated as regular income. Outside of Social Security, other forms of retirement income are taxed at the flat income rate.
